

Terms of Service

1. Acceptance of Terms

By accessing or using the Kat Discord bot ("Kat", "the Service"), you agree to be legally bound by these Terms of Service ("Terms"). If you do not agree with any of these Terms, you must immediately stop using the Service. These Terms apply to all users, administrators, and servers that interact with Kat.

2. Description of Service

Kat is a Discord bot providing server management, moderation, welcome messages, role management, ranking systems, and other community tools. Kat is operated independently and is not affiliated with, endorsed by, or sponsored by Discord Inc.

3. Eligibility

You must be at least 13 years of age to use the Service, in compliance with Discord's Terms of Service. By using Kat, you represent and warrant that you meet this requirement. If you are under 18, you represent that your parent or legal guardian has reviewed and agreed to these Terms.

4. Prohibited Conduct

You agree not to use the Service to:

- Violate any applicable local, national, or international laws or regulations.
- Harass, threaten, abuse, or harm other users or server members.
- Distribute spam, malware, or any harmful content through bot commands.
- Exploit bugs, vulnerabilities, or unintended behaviors of the Service.
- Automate interactions with the bot using unauthorized scripts or macros.
- Impersonate Kat, its administrators, or any other person or entity.
- Attempt to gain unauthorized access to the Service's systems or infrastructure.
- Use the Service for any commercial purpose without prior written consent.
- Reverse engineer, decompile, or attempt to extract source code from the Service.

Kat reserves the right to restrict, suspend, or permanently ban any user or server that violates these Terms without prior notice.

5. Bot Rules

When using Kat, you must comply with the following behavioral rules:

- Do not abuse or spam bot commands in a way that degrades performance for other users.
- Do not use Kat to facilitate, organize, or promote illegal activities.
- Do not configure Kat to send content that is discriminatory, hateful, or violates Discord's Community Guidelines.
- Server administrators are responsible for ensuring Kat is configured appropriately within their servers.
- Do not share, sell, or transfer your Kat premium subscription to third parties.

6. Premium Services

Kat offers optional paid features ("Premium"). By purchasing Premium, you agree to the pricing and features described at the time of purchase. Premium features are subject to change. Payments are processed through MercadoPago and/or PayPal. All transactions are subject to the terms of those respective platforms. Kat is not responsible for payment processing errors or disputes that originate from those third-party platforms.

7. Intellectual Property

All code, design, branding, and content associated with Kat are the exclusive property of the Kat developer. You are granted a limited, non-exclusive, non-transferable license to use the Service for its intended purpose. You may not copy, reproduce, distribute, or create derivative works from Kat without explicit written permission.

8. Disclaimer of Warranties

The Service is provided "AS IS" and "AS AVAILABLE" without warranties of any kind, either express or implied. Kat does not warrant that the Service will be uninterrupted, error-free, or free of harmful components. Your use of the Service is at your sole risk.

9. Limitation of Liability
